In the identified area, the current year population is 130,650 . In 2020, the Census count in the area was 128,671 . The rate of change since 2020 was $0.68 \%$ annually. The five-year projection for the population in the area is 132,419 representing a change of $0.27 \%$ annually from 2022 to 2027. Currently, the population is $48.2 \%$ male and $51.8 \%$ female.

## Median Age

The median age in this area is 27.9, compared to U.S. median age of 38.9.


Persons of Hispanic origin represent $11.2 \%$ of the population in the identified area compared to $19.0 \%$ of the U.S. population. Persons of Hispanic Origin may be of any race. The Diversity Index, which measures the probability that two people from the same area will be from different race/ethnic groups, is 67.4 in the identified area, compared to 71.6 for the U.S. as a whole.
