## Median Age

The median age in this area is 43.5, compared to U.S. median age of 38.9.

Currently, $61.0 \%$ of the 12,271 housing units in the area are owner occupied; $25.5 \%$, renter occupied; and $13.5 \%$ are vacant. Currently, in the U.S., $58.2 \%$ of the housing units in the area are owner occupied; $31.8 \%$ are renter occupied; and $10.0 \%$ are vacant. In 2020, there were 12,317 housing units in the area and $13.8 \%$ vacant housing units. The annual rate of change in housing units since 2020 is $-0.17 \%$.
